Sub:- Invitation of applications for the post of Member, Rajasthan Electricity Regulatory Commission (RERC).

Sir,

The Rajasthan Electricity Regulatory Commission (RERC) was set up in 1999 under Section 17 (1) of the Electricity Regulatory Commissions Act, 1998 (Act No. 14 of 1998) and continues as such for purposes of the Electricity Act, 2003.

The tenure of present Member of the Commission is going to complete on 14.12.2016. It is proposed to fill up this vacancy. Appointment to the post of Member of the Commission is governed by the relevant provisions of the Electricity Act, 2003.

Section 84 of the Electricity Act, 2003 inter alia states that, the Member of the State Commission has to be person of ability, integrity and standing who have adequate knowledge of, and have shown capacity in, dealing with problems relating to Engineering. It has further been prescribed that the Member of the State Commission shall not hold any other office. As per Section 89 of the Electricity Act, 2003, the Member shall hold office for a term of five years from the date on which he/she enters upon his/her office or till he/she attains the age of sixty five years, whichever is earlier. The candidate will have to give a declaration that he/she does not have any financial or other interest, which is likely to affect prejudicially his/her functions as Member of the Rajasthan Electricity Regulatory Commission.

The terms of appointment shall be in accordance with the provisions of Electricity Act, 2003 including the person appointed shall have to resign or opt for voluntary retirement from the services or organization to which he/she belongs.

The Member shall receive a pay of Rs. 67,020/- per month fixed (minus pension including the commutation portion drawn from previous services, if any, where the Member is a retired officer). The Member who is living in his own house would get HRA as admissible to the corresponding grade officers of IAS in the State w.e.f. 1.9.2008. If Member lived in rented house, he would get HRA on actual basis subject to maximum of Rs. 13400/- w.e.f. 1.9.2008. The Member of the Commission would get Car allowance of Rs. 7000/- plus Dearness Allowance thereon w.e.f. 1.9.2008. The salary and allowances are likely to be revised after decision of 7th CPC recommendations.


