**NOTIFICATION**

Whereas the draft of the Karnataka General Services (Administrative Training Institute and District Training Institutes) (Cadre and Recruitment) Rules, 1995 was published as required by sub-section (2) of section-3 of the Karnataka State Civil Services Act, 1978 (Karnataka Act-14 of 1990) in Notification No: LPAR 65 SRE 94, dated: 6th February 1995 in Part-IV section-20(1) of Karnataka Gazette (Extraordinary) dated: 6th February 1995 inviting objections and suggestions from all persons likely to be affected thereby within thirty days from the date of its publication in the Official Gazette.

And whereas the said Gazette was made available to the public on 6th February 1995.

No objections and suggestions have been received by the Government. The suggestions made by Karnataka Public Service Commission have been examined by the Government.

1. Title and Commencement:- (1) These rules may be called the Karnataka General Services (Administrative Training Institute and District Training Institutes) (Cadre and Recruitment) Rules, 1995.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Method of Recruitment and Minimum Qualification:- Category of posts, scale of pay, total number and nature of posts, method of recruitment and minimum qualification:-

There shall be an established State Services Unit in respect of the Karnataka General Services (Administrative Training Institute and District Training Institutes) in respect of the Category, of posts specified in column (2) of the Schedule and the scale of pay, the number of posts, the method of Recruitment and minimum qualification, if any, shall be as specified in the corresponding entries in column (2) (3), (4) and (5) thereof.
